MOORERS

Prospective mooring members must pay 3 months mooring in advance, dating from the time the boat arrives at the club. In the event membership is not offered a rebate will be paid.

CLUB OPENING

Sunday lunchtime 12.00 pm – 2.00pm

The bar is staffed by club members, on a rota basis, one session per month. This is a good way to meet and get to know people. Full training is given.

CRUISES

The club Commodore, with the help of the social team, for the enjoyment of members and friends weekend and full week cruises. Boating members are encouraged to join in these events.

SOCIAL EVENTS

IMPORTANT – COMMITMENT REQUIRED

The club is dependant on the membership, full or associate. The clubhouse and the grounds depend on YOU. WBC Ltd is NOT a pub or a commercial marina, the profit (and loss) is YOURS.

To keep costs low, it is important that members are prepared to support their club and help with maintenance of the club and grounds.

All Membership starts with a six-month 'Introductory Period' and during this time you must show that you are prepared to offer your ccommitment by supporting the club.

Mooring members will be expected to attend work parties

There will be a second interview at the end of six months. On full acceptance members are required to take part in club activities. Mooring members are also required to attend a minimum of 5 work parties (record of work party attendance is kept) or 10 hours alternative work, such as bar rota.
